

# An Overview of Tax Provisions Expiring in 2012

# Summary

A number of tax provisions either expired in 2011 or are scheduled to expire at the end of 2012. These include the following:

- The Bush tax cuts, which reduced income taxes by reducing tax rates, reducing the marriage penalty, repealing limitations on personal exemptions and itemized deductions (PEP and Pease, respectively), expanding refundable credits, and modifying education tax incentives. The Bush tax cuts also reduced estate tax liabilities by increasing the amount of an estate exempt from taxation and by lowering the tax rate.
- The alternative minimum tax (AMT) patch, which, by increasing the amount of income that is exempt from the AMT and allowing certain personal credits against the AMT, prevents an estimated 26 million additional taxpayers from owing the AMT.
- The payroll tax cut, which reduced an employee's share of Social Security taxes by two percentage points.
- A variety of previously extended temporary tax provisions, commonly referred to as "tax extenders," which affect individuals, businesses, charitable giving, energy, community development, and disaster relief.

As Congress decides whether to extend these provisions, it may consider the estimated revenue losses associated with their extension. The Congressional Budget Office (CBO) estimated that extending these provisions through 2022, except for the payroll tax cut, which CBO assumes expires as scheduled at the end of 2012, would reduce revenues by \$5.4 trillion between 2013 and 2022. Specifically, over this 10-year budgetary window extending the Bush tax cuts and extending the AMT patch would reduce revenues by \$4.6 trillion, while extending the tax extenders would reduce revenues by \$839 billion. The cost of extending the payroll tax cut for one year (2012) was estimated to be \$114 billion over the 2012-2022 budgetary window.

In addition to budgetary cost, Congress may also consider other factors when evaluating tax policy. For example, when considering extending the Bush tax cuts, policy makers might consider that the majority of the benefits of this policy accrued to the top 20% of taxpayers. They might also evaluate the potential contractionary impact the expiration of these cuts in 2013 may have on the economy, especially since both the scheduled expiration of the payroll tax cut and the enactment of budget cuts as part of the Budget Control Act (P.L. 112-25) are scheduled to go into effect at the same time. Similarly, Congress may examine the cost effectiveness of the payroll tax cut. According to CBO, the short-term stimulus impact of the payroll tax cut is lower than increasing aid to the unemployed or providing additional refundable tax credits to low- and middle-income households, but more stimulative than extending the Bush tax cuts. Finally, Congress may weigh the lower budgetary costs of short-term extensions of tax extenders against the unpredictability for taxpayers that can arise from short-term extensions.

In past years, Congress has extended expiring provisions en masse in one legislative vehicle. In the 112<sup>th</sup> Congress, Members have considered legislation to extend certain provisions, including S. 3412, S. 3413, and H.R. 8, which extend some or all of the Bush tax cuts and the AMT patch. In addition, the Senate may consider S. 3521, which extends certain temporary expiring provisions.

## Introduction

A number of tax provisions have either expired at the end of 2011 or are scheduled to expire at the end of this year.<sup>1</sup> These include the Bush tax cuts, the alternative minimum tax (AMT) patch, the temporary payroll tax cut, and other temporary expiring provisions, many of which are commonly referred to as "tax extenders." Aside from the payroll tax cut, which was extended by the Middle Class Tax Relief and Job Creation Act of 2012 (P.L. 112-96), the most recent law extending many of these provisions was the Tax Relief, Unemployment Insurance Reauthorization and Job Creation Act of 2010 (P.L. 111-312).

This report provides an overview of these expiring provisions. For each provision (or group of provisions), this report first describes the provision ("current law"), followed by a brief overview of legislation related to the provision, then outlines its past cost and if available the cost of its extension ("budgetary cost"), and concludes with a brief discussion of the current debate concerning the policy ("policy debate"). In the case of the Bush tax cuts and tax extenders, where the policies comprise a variety of other provisions, the details of the provisions are provided in accompanying tables.

In past years, Congress has extended expiring provisions en masse in one legislative vehicle.<sup>2</sup> In the 112<sup>th</sup> Congress, Members have yet to consider legislation that would extend all of the provisions discussed in this report past their scheduled expiration, although legislation to extend certain provisions has been considered.<sup>3</sup> Specifically, Congress has considered S. 3412, S. 3413, and H.R. 8, which extend some or all of the Bush tax cuts and the AMT patch. On July 25, 2012, the Senate agreed to S. 3412 by a vote of 51-48, while they rejected an amendment identical to S. 3413 (S.Amndt. 2573 to S. 3412) by a vote of 45-54. Any further action would be on a house-originated tax measure. On August 1, 2012, the House agreed to H.R. 8. In addition, the Senate may consider S. 3521, which extends "tax extenders," other temporary expiring provisions, and the AMT patch.

# **Bush Tax Cuts**

#### **Current Law**

The Bush tax cuts were provisions—enacted into law primarily by the Economic Growth and Tax Relief Reconciliation Act of 2001 (EGTRRA; P.L. 107-16) and the Jobs Growth Tax Relief Reconciliation Act of 2003 (JGTRRA; P.L. 108-27)—which gradually reduced individual income and estate tax liabilities between 2002 and 2010.<sup>4,5</sup> These tax cuts were extended for 2011 and 2012 by the Tax Relief, Unemployment Insurance Reauthorization, and Job Creation Act of 2010 (P.L. 111-312), henceforth referred to as the 2010 Tax Act. Notably, the 2010 Tax Act was enacted under President Obama, not President Bush, although the underlying policy is still commonly referred to as the Bush tax cuts.

The Bush tax cuts lowered income taxes in a variety of ways (detailed in **Table 1**), including by

- reducing tax rates (see the shaded text box with a comparison of 2012 tax brackets under current law versus if the Bush tax cuts had hypothetically expired in 2012);<sup>6</sup>
- reducing long-term capital gains rates and the tax rate on dividends;
- reducing and then repealing income limitations for personal exemptions and itemized deductions (often referred to as PEP and Pease, respectively);<sup>7</sup>

- expanding tax credits, including the earned income tax credit (EITC), the child tax credit, the adoption tax credit, and the dependent care tax credit;
- reducing the marriage penalty; and

• modifying education tax incentives, including Coverdell education saving accounts (ESAs), the student loan interest deduction, and the tax treatment of certain scholarships and fellowships. The Bush tax cuts also created an exclusion for employer-provided educational assistance.

The Bush tax cuts also gradually reduced the estate tax<sup>8</sup> between 2002 and 2009, with a full repeal of the estate tax in 2010. Under EGTRRA, the amount of an estate which was exempt from taxation gradually rose from \$1 million per decedent in 2002 to \$3.5 million per decedent<sup>9</sup> in 2009, while the top tax rate under the estate tax fell from 50% to 45% over the same time period. In 2010, for the first time since 1916, there was no federal estate tax. The 2010 Tax Act reinstated the estate tax, but raised the exemption level and lowered the tax rate in comparison to the estate tax in effect in 2009. Specifically, the exemption amount in 2011 was set at \$5 million per decedent (adjusted for inflation, this amount will equal \$5,120,000 per decedent in 2012) and the top tax rate was set at 35%. The estate tax is scheduled to increase in 2013, with a \$1 million per decedent exemption level and 55% top tax rate.

Finally, the American Recovery and Reinvestment Act of 2009 (ARRA; P.L. 111-5) made modifications to two provisions of the Bush tax cuts and enacted two new tax provisions. Specifically, ARRA's modifications expanded the refundability of the child tax credit and further reduced the marriage penalty of the EITC (described in **Table 1**). These changes were extended along with the Bush tax cuts by the 2010 Tax Act. In addition, ARRA increased the EITC for families with three or more children<sup>10</sup> and enacted a new higher education tax credit—the American Opportunity Tax Credit (AOTC).<sup>11</sup> These tax law changes were also extended through the end of 2012 by the 2010 Tax Act.

#### Legislation Considered to Extend the Bush Tax Cuts

The Senate and the House have considered legislation to extend some or all of the Bush tax cuts and the AMT patch. Specifically, S. 3413 and H.R. 8 would extend all of the current Bush tax cuts (these bills differ on their treatment of a business expensing provision) and extend the current parameters of the estate and gift tax. S. 3412 would extend the Bush tax cuts for taxpayers making under \$200,000 for single filers, \$225,000 for head of household filers, and \$250,000 for married joint filers. In addition, while this bill would not extend the current parameters of the estate tax, it would extend certain ARRA tax provisions.<sup>12</sup> A detailed overview of these bills and a comparison of specific provisions can be found in CRS Report R42622, *An Overview and*

#### **Budgetary Cost**

The 2010 Tax Act's two-year extension of the income and estate tax provisions of the Bush tax cuts (including the four ARRA modifications) reduced revenues by \$475.79 billion over a 10-year budgetary window (2011-2020).<sup>13</sup> Of these revenue losses, \$363.55 billion is attributable to the extension of the income tax provisions of EGTRRA and JGTRRA, \$68.15 billion is attributable to the modified estate tax provision, and \$44.10 billion is attributable to the four ARRA tax provisions discussed above.<sup>14</sup> The Congressional Budget Office (CBO) estimated that the extension of the income and estate tax provisions<sup>15</sup> of the Bush tax cuts and the four ARRA tax provisions through 2022 would cost \$2.84 trillion over a 10-year budgetary window (2013-2022).<sup>16</sup> The debt service associated with extending these provisions was estimated to be \$505 billion over the same time period.

Under S. 3412—which extends the Bush tax cuts for those with income under \$200,000 (single filers)/\$250,000(married joint filers)—the revenue losses from extending the EGTRRA and JGTRRA individual income tax provisions for 2013 are estimated to be \$129.53 billion over the 10-year budgetary window of 2013 through 2022. In addition, the revenue losses from extending temporary tax cut provisions included in ARRA for 2013 are estimated to be \$27.22 billion over the 10-year budgetary window of 2013 through 2022. (Neither H.R. 8 nor S. 3413 would extend these ARRA provisions.) The equivalent revenue losses under S. 3413—which extends the Bush tax cuts for *all income levels*—are estimated to be \$177.49 billion between 2013 through 2022. The equivalent revenue losses under H.R. 8 (which also extends the Bush tax cuts for all income levels) are estimated to be \$178.63 billion between 2013 through 2022.<sup>17</sup> The extension of the current parameters of the estate and gift tax for 2013 included in S. 3413 and H.R. 8 is estimated to result in \$31.21 billion in revenue losses between 2012 through 2022.

#### **Policy Debate**

Supporters and opponents of the Bush tax cuts generally evaluate the Bush tax cuts from different perspectives. Supporters of the tax cuts stress their long-term and short-term economic benefits. Opponents often emphasize that the tax cuts are costly in terms of reduced revenues and that the benefits of this policy disproportionally accrue to the highest income taxpayers.

When the Bush tax cuts were originally proposed, proponents stressed that by reducing marginal tax rates, this policy would lessen some of the distortions taxes had on work, saving, and investment, ultimately boosting long-term growth. For example, by reducing marginal tax rates, individuals would have more take-home pay, theoretically incentivizing them to work more. Ultimately, this increased economic activity would boost long-term economic growth. Some critics have sought to disprove this theory by comparing historical growth rates and marginal tax rates in the United States. They argue that in periods when taxes where raised (the mid to late 1990s for example), growth was higher than in periods when taxes were cut (the 2000s for example). However, comparing growth rates during periods with different tax rates does not necessarily prove that tax policy *did not* impact growth since a variety of other factors, aside from tax rates, differ between these time periods. The results of many economic studies, have shown that tax cuts generally do affect growth (and components of growth).<sup>18</sup> They have also generally shown, however, that the impact of tax cuts on growth is small in relation to the foregone revenue resulting from the cut.<sup>19</sup>

When the Bush tax cuts were being considered by Congress in 2001, the economy had slipped into a recession. Tax-cut advocates were highlighting the short-term stimulative benefits of the tax cuts. Estimates prepared at the time the Bush tax cuts were being considered predicted a short-term stimulative effect.<sup>20</sup> In addition, CBO analysis indicated that reductions in individual income tax rates could have short-term stimulative impacts on the economy, although these effects were estimated to be small.<sup>21</sup> Later analysis concluded that "the tax cuts reduced GDP [gross domestic product] and employment in 2001, and had virtually no effect on those aggregates in 2002."<sup>22</sup> More recent estimates by CBO concluded that the tax cuts had limited

stimulative benefit—estimating that every \$1 dollar of Bush tax cuts resulted in 10 to 60 cents of GDP.<sup>23</sup> Yet, while the Bush tax cuts may not have been an effective short-term stimulus *in response to a recession*, some economists warn that allowing these tax cuts to expire in 2013, at the same time as a scheduled fiscal contraction, may have a negative effect on the economy.<sup>24</sup>

Opponents of the Bush tax cuts highlight both their high cost as well as the fact that most of the benefits go to upper-income taxpayers. Recent estimates by CBO indicate that the Bush tax cuts, whose cost were not offset, increased the deficit by \$1.75 trillion over the past 10 years (2002-2011).<sup>25</sup> Estimates indicate that approximately two-thirds of the benefits of these cuts accrued to the top 20% of taxpayers with the highest income<sup>26</sup> and over one quarter (26.5%) of the benefits of the Bush tax cuts accrued to the top 1%.<sup>27</sup> By contrast less than a fifth of the benefits (16.5%) accrued to the bottom 60% of taxpayers.<sup>28</sup> Critics charge that this distribution of benefits is "unfair." In response, supporters of the tax cuts approach the "fairness" of the tax cuts from a different perspective. They highlight that higher income taxpayers pay a greater share of federal taxes, and the tax cut was fair in so far as it benefitted the taxpayers with the highest tax burdens. According to CBO, the top 20% of households in the income distribution pay more than two-thirds (68.9%) of all federal tax liabilities, while the top 1% of households pays more than a quarter of all Federal taxes (28.1%).<sup>29</sup>

Another perspective on the "fairness" of these tax cuts that opponents of this policy highlight is their distributional impact on after-tax income. According to estimates examining tax burdens in 2010, the Bush tax cuts resulted in the lowest 20% of taxpayers seeing their income rise by 0.5%, while the top 20% saw their after-tax incomes rise by 4.9% and the top 1% saw their income rise by 6.6%.<sup>30</sup>

The distributional impact of the Bush tax cuts may be relevant to policy makers if they are concerned with growing income inequality in the United States.<sup>31</sup> A recent CBO report highlighted that while the main driver of increasing after-tax income inequality was the increasing concentration of *pre-tax income* among the wealthiest Americans, government transfers and federal tax policy also contributed to the growth of after-tax income inequality.<sup>32</sup> As the CBO report indicated, the equalizing impact of taxes depends on their progressivity,<sup>33</sup> with increasing progressivity reducing income inequality (holding the size of tax receipts constant).<sup>34</sup> The Bush tax cuts overall reduced the progressivity of federal income taxes<sup>35</sup> and hence were a factor in increases in income inequality in the United States.

When evaluated separately, some Bush tax cut provisions increased income inequality, while others contributed to a decrease in income inequality. Recent CRS analysis found that the lowering of tax rates, the repeal of PEP and Pease, and the reduced taxes on capital gains and dividends increased income inequality. Alternatively, the expansion of the child tax credit and EITC were found to reduce income inequality.<sup>36</sup>

# AMT Patch

#### **Current Law**

The Alternative Minimum Tax (AMT) was designed to ensure that higher-income taxpayers who owed little or no taxes under the regular income tax because they could claim tax preferences would still pay some tax.<sup>37</sup> When calculating the AMT, taxpayers first add back various "tax preference items" (like certain deductions) to their taxable income, to determine the amount of income subject to the AMT (the "AMT tax base"). Second, taxpayers subtract a basic exemption amount from their AMT tax base. Third, a two-tiered rate structure of 26% and 28% is assessed against the AMT tax base to determine tax liability. Finally, if a taxpayer's AMT is greater than their regular tax liability, the taxpayer pays the difference in addition to their regular tax liability (the difference paid is technically the AMT). Crucially, unlike the regular income tax, key parts of the AMT—including the exemption amounts—are not indexed for inflation. This means in a typical year, as a result of inflation increasing taxpayers' nominal income levels, additional taxpayers are subject to the AMT.

The Bush tax cuts temporarily increased the exemption amount under the AMT. This temporary increase in the exemption amount, known as the AMT patch, was extended several more times<sup>38</sup>—most recently by P.L. 111-312—and was in effect through the end of 2011.<sup>39</sup> In 2011, the AMT-exemption amounts were \$74,450 for married individuals filing joint returns and \$48,450 for unmarried individuals. These exemption amounts revert to \$45,000 for married individuals and \$33,750 for unmarried individuals in 2012.<sup>40</sup> In addition, an AMT patch generally has also included a provision which allowed taxpayers to reduce their AMT by nonrefundable personal tax credits.<sup>41</sup> In 2012, under current law, most nonrefundable personal credits will no longer be allowed against the AMT.

## Legislation Considered to Extend the AMT Patch

The Senate and the House have considered legislation to extend the AMT patch as part of broader legislation to extend some or all of the Bush tax cuts. S. 3412 would extend the AMT patch for one year, 2012, while S. 3413 and H.R. 8 would extend the AMT patch for two years, 2012 and 2013. Under all three bills, the exemption amounts in 2012 would be raised to \$50,600 for individuals and \$78,750 for married joint filers. S. 3413 and H.R. 8 would raise the exemption

amounts to \$51,150 for individuals and \$79,850 for married joint filers. In addition all three bills would allow nonrefundable personal credits against the AMT for 2012, and S. 3413 and H.R. 8 would also allow nonrefundable credits against the AMT in 2013. A detailed overview of these bills and a comparison of these three bills can be found in CRS Report R42622, *An Overview and Comparison of Proposals to Extend the "Bush Tax Cuts": S. 3412, S. 3413, H.R. 8*, by Margot L. Crandall-Hollick.

The Senate may consider legislation to extend certain expiring tax provisions and tax extenders. This legislation, S. 3521, the Family Business and Tax Cut Certainty Act of 2012, would also extend the AMT patch for two years—2012 and 2013.

#### **Budgetary Cost**

The cost of AMT patches will depend on whether current tax policy (i.e., the Bush tax cuts) is also extended. Generally, for taxpayers subject to the AMT, the lower their taxes under the regular income tax system, the higher their AMT and, hence, the greater the cost to patch the AMT. Thus, the cost of AMT patch would be expected to be higher if the Bush tax cuts—which generally lowered taxes—were in effect as compared to if they were not in effect, all else being equal. CBO estimates indicate that revenue losses from extending the AMT-patch concurrently with the Bush tax cuts are larger than only extending the AMT-patch and allowing the Bush tax cuts to expire.

The cost of indexing the AMT to inflation through 2022, assuming current law (i.e., the Bush tax cuts expire), is estimated to be \$804 billion over 10 years, 2013-2022 (plus an additional \$133 billion in debt service over the same time period).<sup>42</sup> CBO estimated that the combined cost of the extension of the Bush tax cuts and the AMT patch would be \$920 billion more than the sum of extending these policies separately, highlighting the interaction between the regular income tax and AMT previously discussed. Specifically, the cost of extending the Bush tax cuts was estimated to be \$2.84 trillion over 10 years (2013-2022), while the cost of extending the AMT patch was estimated to be \$804 billion over the same time period. The cost of extending the policies concurrently was estimated to be \$4.56 trillion between 2013 and 2022 (the debt service associated with a concurrent extension of the Bush tax cuts and the AMT patch was estimated to be an additional \$790 billion between 2013 and 2022).<sup>43</sup>

The revenue losses from extending the AMT patch *for one year*—2012—included as part of S. 3412 (which extended some of the Bush tax cuts for 2013) are estimated to be \$92.04 billion over the 10-year budgetary window of 2013 through 2022. An estimate of the revenue losses of S. 3413's AMT patch provision—which would extend the AMT patch for 2012 and 2013 (and extend all of the Bush tax cuts for 2013)—is currently unavailable. However, the revenue loss estimates of the AMT patch from H.R. 8 (which also extends the patch for two years and all of the Bush tax cuts for 2013) would result in an estimated \$192.73 billion in revenue losses over the 10-year budgetary window of 2013 through 2022. The revenue losses from extending the AMT patch for two years (2012 and 2013) included in S. 3521 would reduce revenues by \$132.24 billion between 2013 through 2022 assuming the Bush tax cuts expire at the end of 2012.

## **Policy Debate**

The current debate on the AMT patch centers around limiting the number of taxpayers subject to the AMT, while also minimizing the revenue losses to the federal government from the AMT patch. The AMT patch, if extended, would reduce the number of taxpayers subject to the AMT by approximately 26 million.<sup>44</sup> Many of these taxpayers are middle- and upper-middle income taxpayers—especially those with children. However, as previously discussed, the patch is costly in terms of lost revenue. Congress may choose to consider indexing the AMT for inflation or it may choose to reform the regular income tax system in such a way that the AMT no longer exists.<sup>45</sup>

# Payroll Tax Cut

## Current Law

The payroll tax cut—initially enacted for 2011 by P.L. 111-312 and extended for 2012 by P.L. 112-78 and P.L. 112-96—reduced the employee's share of Social Security payroll taxes.<sup>46</sup> Specifically, the payroll tax cut reduced the employee's share<sup>47</sup> of Social Security taxes from 6.2% to 4.2% for employees and from 12.4% to 10.4% for the self-employed on the first \$110,100 of wages in 2012.<sup>48</sup>

#### Legislation Considered to Extend the Payroll Tax Cut

There is currently no legislation that has been considered by the House and Senate to extend the payroll tax cut after it expires at the end of 2012.

## **Budgetary Cost**

The total cost of the payroll tax cut for 2011 and 2012 has been estimated to be \$225.7 billion for the 2011-2022 budgetary window.<sup>49</sup> Of this total cost, the 2011 payroll tax cut reduced revenues

by \$111.7 billion between 2011 and 2020, and the 2012 payroll tax cut reduced revenues by \$114.0 billion between 2012 and 2022.<sup>50</sup>

#### **Policy Debate**

The payroll tax cut was intended to provide an economic stimulus by increasing workers' takehome pay. This tax cut benefits virtually all working Americans, but research indicates that this policy may not be as targeted or cost-effective a stimulus as other tax policies or direct-spending programs. Approximately 159 million workers will be eligible for the payroll tax cut in 2012, which on average will equal approximately \$717 per worker.<sup>51</sup> However, the actual value will depend on the taxpayer's wages, with those making \$20,000 receiving an additional \$400 in takehome pay, and those making \$110,100 or more (the Social Security wage cap in 2012) receiving a maximum increase of \$2,202 in take-home pay.

Because the payroll tax cut is not targeted to those facing the greatest fiscal constraints (it is available to 94%<sup>52</sup> of wage earners irrespective of income level), a portion of it may be saved instead of spent, limiting the stimulative impact of this policy.<sup>53</sup> The Congressional Budget Office—which assumed that the majority of the increase in disposable income would be saved or used to pay down debt rather than spent on goods and services—estimated that a temporary reduction of payroll taxes would raise output cumulatively in the next two years by between 10 and 90 cents per dollar of total budgetary cost and would increase employment by between one and nine jobs per million dollars of budgetary cost.<sup>54</sup> According to CBO, the short-term stimulus impact of the payroll tax cut is lower than increasing aid to unemployed or providing additional refundable tax credits to low- and middle-income households (but on par with extending the AMT-patch). However, the same report indicated that the payroll tax cut was more stimulative in the short term than extending the Bush tax cuts. In addition, at the end of 2011 when the payroll tax cut was originally scheduled to expire, several economic reports indicated that its expiration could hamper economic growth.<sup>55</sup> Finally, policymakers may be concerned that this temporary provision could become a provision which is routinely extended. They may be concerned about the budgetary impact of these routine extensions. Or they may have concerns that routine extensions will negatively impact the Social Security trust fund, although the current payroll tax cut requires that the Social Security trust funds be "made whole" by a transfer of general revenue.

# Other Expiring Provisions and "Tax Extenders"

#### **Current Law**

In addition to temporary income, estate, AMT, and payroll tax provisions, Congress has enacted a variety of temporary tax provisions that either expired at the end of 2011 or are scheduled to expire at the end of 2012.<sup>56</sup> These provisions generally fall into one of six categories: those related to individuals, businesses, charitable giving, energy, community development, or disaster relief. **Table 2** provides a list of provisions that expired in 2011 or are scheduled to expire at the end of 2012, including information on the estimated 10-year cost of extending the provision for one year. In addition, the table includes information as to whether S. 3521 would extend the provision (this bill extends all expired in 2011 or are scheduled to expire at the end of 2012 have been *routinely* extended on a short-term basis, and are hence commonly referred to as "tax extenders," there are a variety of expiring provisions that have not been previously extended. Both traditional "tax extenders" and these new expiring provisions are included in **Table 2**.

#### Individual

Several temporary tax provisions affecting individuals either expired at the end of 2011 or are scheduled to expire at the end of 2012. Of these, the largest in terms of estimated revenue losses include the deduction for state and local sales taxes;<sup>57</sup> the refundability of the credit for prior minimum tax liability; the above-the-line deduction for qualified tuition and related expenses;<sup>58</sup> the deduction of mortgage insurance premiums as qualified interest; the expansion of the adoption credit and adoption assistance programs;<sup>59</sup> the above-the-line deduction for certain expenses of elementary and secondary school teachers;<sup>60</sup> and the parity in the tax treatment of employer-provided transit benefits to parking benefits.

#### Business

Several temporary tax provisions affecting businesses either expired at the end of 2011 or are scheduled to expire at the end of 2012. Of these, the largest in terms of estimated revenue losses include bonus depreciation in 2011 and 2012, whereby a 100% bonus depreciation allowance is in effect through the end of 2011, set to decrease to 50% for 2012 and expire after December 31,

2012; the research and experimentation credit;<sup>61</sup> the exception under Subpart F for active financing income earned by banking, financing, and insurance business operations abroad;<sup>62</sup> the enhanced cost-recovery for qualified leasehold, restaurant, and retail improvements; and the enhanced expensing allowances which allow businesses to expense \$500,000 for investment in qualified investment in 2011, \$125,000 in 2012, and \$25,000 thereafter.<sup>63</sup>

#### Charitable

Several temporary provisions designed to incentivize charitable giving<sup>64</sup> expired at the end of 2011. Of these, the largest in terms of estimated revenue losses include tax-free distributions from IRAs for the purposes of charitable donations; enhanced charitable deductions for corporate contributions of computer equipment for education purposes; and enhanced charitable deductions for contributions of food inventory.

#### Energy

Several temporary provisions affecting the energy sector, including alternative energy, expired at the end of 2011 or are scheduled to expire at the end of 2012. Of these, the largest in terms of estimated revenue losses include incentives for alcohol fuels (primarily ethanol); incentives for biodiesel and renewable diesel;<sup>65</sup> the Section 1603 grants-in-lieu of tax credit;<sup>66</sup> the placed-inservice date for the production tax credit for wind; and the credit for nonbusiness energy property (sometimes referred to as the "25C credit").<sup>67</sup>

#### **Community Development**

Several provisions to promote community development expired at the end of 2011. These include qualified zone academy bonds, which are available to state and local governments for elementary and secondary school renovation, equipment, teacher training, and course materials; the new markets tax credit (NMTC), which is designed to promote investment in low-income and impoverished communities;<sup>68</sup> and tax incentives to encourage economic activity in empowerment zones,<sup>24</sup> the District of Columbia (DC), and in the American Samoa.<sup>69</sup>

#### **Disaster Relief Provisions**

A number of disaster-related tax provisions expired at the end of 2011 or are scheduled to expire at the end of 2012. They include provisions designed to help redevelopment of the New York Liberty Zone and the Gulf Opportunity (GO) Zone,<sup>70</sup> as well as provisions to provide relief following the Midwestern storms and Hurricane Ike in 2008.

## Legislation Considered to Extend Certain Expiring Provisions and Tax Extenders

The Senate may consider S. 3521, the Family and Business Tax Cut Act of 2012, which extends some, though not all, of the expiring provisions detailed in **Table 2** through the end of 2013. **Table 2** includes information on whether a particular provision is extended by S. 3521 and the 10-year (2013-2022) revenue loss estimates associated with extending the provision through the end of 2013.<sup>71</sup>

## **Budgetary Cost**

The revenue losses from extending the tax extender provisions depends on which provisions are extended and the duration of the extension. The Joint Committee on Taxation (JCT) estimated that the cost of extending temporary provisions that expired in 2011 through the end of 2012 was \$42.92 billion dollars over the 2012-2021 budgetary window.<sup>72</sup> By contrast, the JCT estimated that the cost of extending certain expiring provisions through the end of 2013 was \$205.06 billion over the 10-year period of 2013 through 2022.<sup>73</sup>The U.S. Treasury estimated that extending *certain* temporary provisions that expired in 2011 and 2012 through the end of 2013 was \$26 billion over the 2013-2022 budgetary window.<sup>74</sup> CBO estimated that the revenue losses from extending temporary provisions<sup>75</sup> for a longer period than one or two years—through 2022—would reduce revenues by \$839 billion over the 2013-2022 budgetary window.<sup>76</sup> The debt service associated with financing these extensions was estimated to be \$173 billion over the same period.

## **Policy Debate**

Congress may enact tax provisions on a temporary basis for a variety of reasons, including to provide short-term stimulus (e.g., the enhanced expensing provisions), to provide short-term disaster relief, or to encourage Congress to re-evaluate the efficacy of these provisions on a routine basis. The budgetary cost of a short-term extension is less than the cost of a longer-term extension, which some analysts contend is a major reason that these provisions are extended on a short-term basis.<sup>77</sup> At a recent Senate Finance Committee hearing on tax extenders, Dr. Roseanne Altshuler stated

...temporary tax legislation may simply (but sadly) be the result of Congress playing a budget game. The Congressional Budget Office (CBO) must project the revenue baseline using current law. This means that the CBO must assume that temporary provisions expire as scheduled. If, as past history would strongly suggest, temporary provisions are never allowed to lapse, then they effectively become permanent feature of the code that are not accounted for in the revenue baseline. Since almost all extenders involve tax cuts, the assumption they will be terminated tends to make the CBO project a healthier revenue baseline than is likely to occur.<sup>78</sup>

But while the temporary nature of these provisions and the resulting budgetary score may make them more politically palatable, some policymakers contend that the temporary nature of these provisions, and the uncertainty about whether they will be extended, limits their ability to achieve their policy objectives.<sup>79</sup>

- a. This law was the first law to enact this provision.
- b. At enactment, this provision was estimated to result in a revenue gain of less than \$1 million over the 2009-2018 budgetary window (JCX-80-08).
- c. At enactment, this provision was estimated to result in \$33 million in revenue losses over the 2008-2018 budgetary window (JCX-64-08).
- d. A proposed extension of this provision is estimated to result in \$430 million in revenue losses over the 2013-2022 budgetary window (FY2013 Greenbook).
- e. At enactment, this provision was estimated to result in \$8 million in revenue losses over the 2011-2020 budgetary window (JCX-54-10).
- f. This cost estimate reflects the cost over the 2013-2022 budgetary window of extending this provision through the end of 2013. These revenue loss estimates are from Table 4 of the FY2013 Treasury Greenbook.
- g. A proposed extension of this provision is estimated to result in \$4 million in revenue losses over the 2013-2022 budgetary window (FY2013 Greenbook).

The placed in service date for the PTC for wind was scheduled to expire at the end of 2012, while the placed in service date for the PTC for other renewable technologies were generally scheduled to expire at the end of 2013. Prior to S. 3521, extensions of the PTC extended the placed-in-service date for eligible properties. Hence if a wind facility was operating prior to the expiration date, they would be eligible for the credit. The extension of the PTC for wind included a provision that modified the expiration date for all renewable technologies (including wind) such that qualified facilities will be eligible for the PTC (or the investment tax credit in lieu of the production tax credit, if the construction—as opposed to the placed in service date—begins prior to the end of 2013.
- x. This provision raises \$12 million between the 10-year budgetary window of 2013 through 2022.
- y. S. 3521 expands qualified cellulosic biofuel production to include algae-based fuel.
- z. A previous extension of this provision was estimated to result in \$362 million in revenue losses over the 2009-2018 budgetary window (JCX-78-08).

# **Concluding Remarks**

As Congress decides whether to extend some or all of these expiring tax provisions, it may consider several options. It may choose to extend all expiring tax provisions. CBO estimated that extending these provisions through 2022 (except for the payroll tax cut, which CBO assumes expires as scheduled at the end of 2012) would reduce revenues by \$5.4 trillion between 2013 and 2022. Specifically, over this 10-year budgetary window, extending the Bush tax cuts and extending the AMT patch would reduce revenues by \$4.6 trillion, while extending other expiring provisions and "tax extenders" would reduce revenues by \$839 billion. The cost of extending the payroll tax cut for one year (2012) was estimated to be \$114 billion over the 2012-2022 budgetary window. The extension of these provisions, if they are not offset, would increase the 10-year cumulative (2013-2022) deficit from \$3.07 trillion to \$9.44 trillion (including \$963 billion in debt service between 2013 and 2022). This would result in projected deficits as a percentage of GDP (a measure of deficits in proportion to the economy) rising from 1.5% to 4.7%, a figure many economists view as unsustainable.<sup>80</sup> The deficit would be even higher if the payroll tax cut is extended again and is not offset.

Congress may instead choose to allow all temporary provisions to expire. According to CBO, this will result in a considerable rise in revenue that will have a significant effect on reducing the projected future deficit.<sup>81</sup> However, some economists warn that the scheduled expiration of these temporary provisions, which would occur simultaneously with the scheduled expiration of emergency unemployment insurance benefits and scheduled budget cuts under the Budget Control Act, would reduce real GDP growth.<sup>82</sup>

Finally, Congress may choose to balance the objectives of deficit reduction and economic assistance by extending certain provisions it determines are effective, while letting others expire. Alternatively, Congress may pursue this objective by considering a fundamental reform of the tax code.<sup>83</sup>

Prior CRS analysis estimated that annual budget deficits would need to be no larger than 2.5% to 3.0% of GDP over the next 10 years in order to stabilize the debt as a share of GDP at its projected 2011 level (69% of GDP).
